2026 - 2027 Policies and Guidelines

- _____ 1. \$35 Registration fee and \$25 Recital fee are due at the time of registration to reserve your spot!
Registration fees are waived during the month of April. Recital fees are \$25 per family. There are no refunds on Registration and Recital fees.
- _____ 2. The non-refundable Recital Fee will include 2 tickets per family to our Spring Recital.
- _____ 3. A 10% discount will be applied if you pay the full year Tuition by September 1st. A 5% discount is applied to each additional sibling. Tuition is non-refundable.
- _____ 4. Tuition is due by the 15th of each month. If you sign up for Automatic Payments, your Tuition will be charged to your account on the 15th of each month.
- _____ 5. If Tuition is not paid by the 15th of the month, there will be a \$25 late fee added to your account.
- _____ 6. All Tuition, Registration Fees, Recital Fees, Costume Fees, and other fees associated with Legacy Dance Productions are non-refundable.
- _____ 7. Like any other sport or activity there is always the element of risk. Parents and students agree that Legacy Dance Productions, its teachers, landlords, and employees are not responsible for any injuries in the building or surrounding properties.
- _____ 8. Legacy Dance Productions is not responsible for lost or stolen items.
- _____ 9. Proper dance attire is required for all classes, along with the appropriate shoes. Shoes may be purchased through Legacy or from another retailer, as long as they match the required style.
- _____ 10. Dancers are free to wear what they are comfortable in for class. No baggy clothing or jeans are to be worn.
- _____ 11. Legacy Dance Productions has the right to cancel any classes due to low enrollment. Class cancellations will be made by October 1st at the owner's discretion. All students will be given the option of an alternate class.
- _____ 12. If your child wishes to withdraw from a class, you must come into the office and complete a withdraw form one month in advance. No refunds are given. You will be able to pick up your child's costume when the costumes come in.
- _____ 13. If Legacy Dance Productions must cancel classes due to extreme weather out of our control, a make-up class will be offered. No refunds are given for missed classes. We will email and post on social media if classes are canceled for any reason.

- _____ 14. No food, drink (other than water), or gum is allowed in the dance studios. Food must be kept in the lobby area.
- _____ 15. Legacy Dance Productions will be closed for all major holidays and school breaks (Labor Day, Thanksgiving break, Christmas break, Spring break). We will not be closed on teacher workdays or early release days.
- _____ 16. Legacy Dance Productions is not responsible for providing before or after class care for the students. Please do not arrive more than 15 minutes before class time.
- _____ 17. We will post all important dates on our website calendar, social media, and BAND App. We will also have information posted on the bulletin board in the lobby. It is the parent's responsibility to stay informed.
- _____ 18. Parents or guardians are not allowed in the classrooms. We ask that you wait in the lobby or return after class to pick up your student.
- _____ 19. Students are expected to be well-behaved and to show respect to their teachers, classmates, and parents.
- _____ 20. Students may sit and do homework in our lobby while waiting for their class to begin. They are not permitted to enter or disrupt other classes that are in progress.
- _____ 21. Students are not permitted to have cell phones or watches in the classroom at any time.
- _____ 22. Legacy Dance Productions has permission to take photographs of the student to use on social media, advertisements, and other promotional materials.
- _____ 23. Legacy Dance Productions Spring Recital will be held in June at Louisburg College. (Dates and will be announced later in the year). All competitive and non-competitive students are expected to participate.
